Dear Members,

Please be informed that Manila Water Company, Inc. (MWCI) will be undertaking a line meter declogging at Dela Rosa corner Legazpi, Ayala Avenue corner Buendia (RCBC Tower) and Greenbelt Avenue corner Makati Avenue and Arnaiz Avenue (Legazpi Village, Makati City). Details of the activity are as follows:

The interruption will start from May 25, 2022 at 10:00 PM to May 26, 2022 at 5:00 AM. With this, the following streets will have temporary water service interruption (Low Pressure to No Water).

Dela Rosa from V.A Rufino, V.A Rufino to Legazpi, Rodriguez Castro, Palanca, Gil, Paseo de Roxas, Perea, Gallardo, Legazpi, Dela Rosa corner Amorsolo to Dela Rosa Legazpi, Amorsolo corner Dela Rosa to V.A. Rufino, Ayala Avenue from Dela Rosa to Makati Avenue, Adelantado, Salcedo, Sotto, Bolanos, Esteban, Ormaza, Gamboa, Trasierra, Jimenez, Benavidez, Esperanza, A. Arnaiz from Makati Avenue to Amorsolo.

The member buildings on the said areas will experience no water supply.

With this, we are advising you to store enough water prior to the schedule of the water interruption.
