TO : ALL MEMBERS/BUILDING ADMINISTRATORS
SUBJECT : GENERAL COMMUNITY QUARANTINE – ALERT LEVEL 2

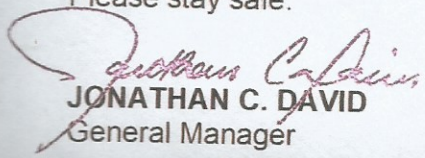
Pursuant to the proclamation issued by the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases, therein placing the National Capital Region (NCR) under "General Community Quarantine – Alert Level 2" from February 1, 2022 to February 15, 2022.

The following guidelines shall be implemented within MACEA, subject to the declaration and implementation of granular lockdown in areas identified by the LGU as "critical zones":

1. Indoor dine-in services in restaurants shall be allowed up to fifty percent (50%) venue/seating capacity for fully vaccinated customers and minors, even if unvaccinated.
2. Outdoor or al fresco dine-in services may be allowed up to seventy (70%) venue/seating capacity.
3. Personal care services including beauty salons, beauty parlors, barbershops, and nail spas shall be allowed up to fifty percent (50%) indoor venue/seating capacity only for fully vaccinated individuals and those under 18 years old, even if unvaccinated. Outdoor areas shall be allowed up to seventy (70%) venue/seating capacity.
4. Religious gathering shall be allowed up to fifty percent (50%) indoor venue/seating capacity only for fully vaccinated individuals and those under 18 years old, even if unvaccinated. Outdoor areas shall be allowed up to seventy (70%) venue/seating capacity.
5. Public transportation shall remain operational at such capacities and protocols in accordance with the guidelines issued by the Department of Transportation (DOTr).
6. All ages are allowed to move around subject to restrictions to be determined by the LGU based on comorbidities or vaccination status.
7. Individual outdoor exercises shall be allowed for all ages regardless of comorbidities or vaccination status provided that the minimum public health standards and social distancing protocols are observed.
8. Gyms, tourist attractions, libraries, museums, concerts, parties, wedding receptions, family reunions, motorcades, amusement parks, recreational venues, cinemas and movie houses, funfairs/peryas, kid amusement industries, karaoke bars, concert halls, theaters shall be allowed up to fifty percent (50%) indoor venue/seating capacity only for fully vaccinated individuals and those under 18 years old, even if unvaccinated. Outdoor areas shall be allowed up to seventy (70%) venue/seating capacity.
9. Film, music, and television production (subject to the joint guidelines may be issued by the DTI, DOLE, and the DOH) shall be allowed up to fifty percent (50%) indoor venue/seating capacity only for fully vaccinated individuals and those under 18 years old, even if unvaccinated. Outdoor areas shall be allowed up to seventy (70%) venue/seating capacity.
10. Casinos, horse racing, cockfighting and operation of cockpits, lottery and betting shops, and other gaming establishments shall not be allowed to operate, or be undertaken.

MACEA enjoins everyone to be cautious and compliant to the policies issued and enforced by IATF. We shall keep you posted should there be any latest announcements from the government for proper guidance of all concerned.
