Rufino)**, and **Paseo de Roxas (from corner Dela Rosa to corner Villar)** will be closed to vehicular traffic for the **Rosas ng Sampiro Festival 2024** in Ayala Avenue. 2	From EDSA	Take Ayala Avenue then turn right to Apartment Ridge or turn left to Courtyard Drive
3	For Public Utility Buses (PUB)	Take Gil Puyat/Buendia
4	For Public Utility Jeep (PUJ)	Take Arnaiz Avenue and turn left on Makati Avenue

Please be advised that traffic marshals and traffic control devices will be deployed to ensure continuous traffic flow.
