## MEMORANDUM CIRCULAR 2019-04

TO : ALL MEMBERS

RE : ROAD AND SIDEWALK USAGE FEES

### Board Resolution No. BG-02/19-09

**WHEREAS**, there has been an increase in applications for roadworks by various utility and telecommunications providers within the MaCEA Area;

**WHEREAS**, such increase has resulted in disruption to traffic;

**WHEREAS**, the Corporation does not currently impose any charge or fee in relation to such works other than the actual cost of restoration;

**WHEREAS**, the imposition of additional fees shall allow the Corporation to properly maintain and restore the condition of the roads in the MaCEA Area and encourage use of the Underground Conduit Network Project;

**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby resolved that the Board approves the **imposition of Road Usage Fees within the MaCEA Area effective April 01, 2019** in accordance with the following schedule:

**WHEREAS**, there has been an increase in applications for excavation works by various companies at or near pedestrian sidewalks within the MaCEA Area;

**WHEREAS**, such applications have been shown to encroach upon such sidewalks, and thus disrupt and inconvenience residents and workers within the MaCEA Area;

**WHEREAS**, the Corporation does not currently impose any charge or fee in relation to such works other than the actual cost of restoration;

**WHEREAS**, the imposition of additional fees shall allow the Corporation to properly maintain and restore the condition of the sidewalks in the MaCEA Area;

**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby resolved that the Board approves the **imposition of Sidewalk Usage Fees effective April 01, 2019 within the MaCEA Area** in accordance with the following schedule:
