MEMORANDUM CIRCULAR 2020-18

TO : **ALL MEMBERS AND LOCATORS**
SUBJECT : **GENERAL COMMUNITY QUARANTINE**

Pursuant to Resolution No. 67, series 2020 issued by the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases on August 31, 2020, National Capital Region (NCR) is placed again under the General Community Quarantine (GCQ) from September 1 to 30, 2020. The following shall be implemented within Barangay Bel-Air, San Lorenzo and Urdaneta, effective September 01, 2020:

1. Strict social distancing shall continue to be observed in all buildings, residential condominiums and public areas. Movement shall be limited to accessing basic necessities and provisions for food and essential health services, and for work in the offices or industries permitted to operate hereunder.
2. Mandatory wearing of face mask shall be strictly implemented. In the workplace, face shields and masks should always be worn together when interacting with colleagues, clients and/or visitors.
3. Outdoor individual or non-contact forms of exercises shall be allowed like outdoor walking (with or without dogs), jogging/running and biking subject to strict observance of safety protocols requiring distance of at least two (2) meters from the next person sideways and at least three (3) meters from the person immediately.
4. The following individual are required to remain in their residences at all times, except when indispensable under the circumstances for obtaining essential goods and services, for work in permitted industries and offices, and for allowed exercise activities:
 - Any persons below 21 years old.
 - Those who are 60 years old and above.
 - Those with immunodeficiency, comorbidities, or other health risks.
 - Pregnant
 - Any person who resides with the aforementioned.
5. Limited operations in malls and shopping centers shall be allowed, except for leisure establishments and services which shall continue to be closed.
6. No hotels or similar establishments shall be allowed to operate, except those accommodating the following:
 - a. Guests who have existing long term-bookings;
 - b. Distressed OFWs and stranded Filipino or foreign nationals;
 - c. Repatriated OFWs in compliance with approved quarantine protocols;
 - d. Non-OFWs who may be required to undergo mandatory facility-based quarantine; and
 - e. Healthcare workers and other employees from exempted establishments under these Revised Omnibus Guidelines and applicable Memoranda from the Executive Secretary.

7. All public and private construction shall be allowed, but with strict compliance to the issued construction safety guidelines for the implementation of infrastructure projects during the COVID-19 pandemic by DPWH.
8. Curfew shall be from 10:00 PM to 5:00 AM in compliance with local government policy.
9. No permit shall be issued by Estate Management for events and mass gatherings. Gatherings may be allowed for a maximum of 10 persons only, if they are authorized, work essential and not entertainment related.

MACEA enjoins everyone to be cautious and compliant to the policies by IATF. We shall keep you posted should there be any latest announcements from the government for proper guidance of all concerned.
